HYDROGRAPHIC SHIPPING DISCLAIMER

BY READING THE FOLLOWING AND SUBMITTING PAYMENT FOR SERVICES YOU ARE AGREEING TO ALL THE FOLLOWING TERMS:

*ALL ITEMS MUST BE TAKEN APART PRIOR TO US RECEIVING THEM. UNLESS IT IS A FIREARM. CAN SHIP WHOLE GUN (NOT LOADED)

*ALL HEAVY DIRTY OR GREASY ITEMS MUST BE CLEANED OR ADDITIONAL COSTS WILL BE APPLIED @ \$50/HR SHOP RATE. TYPICAL GUN LUBE OR NORMAL OIL ON STUFF IS OKAY.

*ANY ITEMS WITH AREAS THAT DO NOT NEED PAINTED/DIPPED MUST HAVE A DETAILED DESCRIPTION OF WHERE THE AREAS ARE ON THE ITEM PRIOR TO THE WORK BEING STARTED.

NOTE HERE:

*THE FINISH ON ANY PROJECT ONLY FINISHED IN A HIGH GLOSS OR MATTE FINISH(NO SHEEN).

*FOR PATTERNS THAT WE DO NOT HAVE IN STOCK. THERE WILL BE A \$70 FEE FOR EXTRA PROCESSING AND

*THERE IS A \$50 AN HOUR SHOP FEE FOR ITEMS THAT ARE OUT OF THE ORDINARY. I WILL VERIFY BEFORE I EXTRA WORK IS DONE.

*ALL SALES ARE FINAL. WE DO OUR BEST TO PROVIDE THE HIGHEST QUALITY AND CUSTOMER SERVICE. DUE TO THE NATURE OF THE BUSINESS, WE CANNOT PROCESS REFUNDS. WE DO OFFER A LIFETIME WARRANTY.

LIFETIME WARRANTY: INCLUDES ANY DEFECT FROM THE CHEMICAL PROCESS. (DELAMINATION OF CLEAR COAT, CHIPPING, PEELING OR FADING.)

DUE TO EVERYTHING HAVING A WEAR TOLERANCE, HYDROGRAPHICS, PAINTING, OR CERAKOTE IS NOT INDESTRUCTIBLE. OVER SEVERE REPETITIVE USE, AREA COULD SHOW EVENTUAL SHOW WEAR. WHICH REPETITIVE WEAR IS NOT WARRANTIED.

*CUSTOMER IS RESPONSIBLE FOR ALL SHIPPING COSTS AND MUST PROVIDE A RETURN LABEL WITH THEIR SHIPMENT TO US. IF ONE IS NOT PRESENT, WE WILL QUOTE YOU ONE FROM OUR SHIPPING COMPANY WE USE. WE WILL ISSUE YOU AN INVOICE FOR RETURN SHIPPING AND ONCE PAID WE WILL SEND OUT YOUR ITEM.

*CUSTOMER IS RESPONSIBLE FOR PROPER PACKAGING FOR SHIPPING AND HANDLING. IF SHIPPING A FIREARM. BY LAW YOU CAN NOT SHIP IN A BOX THAT DISPLAYS THAT A GUN IS INSIDE. MUST BE DISCREET PACKAGING. MUST NOT BE LOADED OR CONTAIN ANY AMMO WHAT SO EVER. You must ship your firearms "Delivery Confirmation Adult Signature Required" and place a sticker on each package indicating that an adult signature is required for delivery.

Gun Shipping Checklist

- 1. Copy of Driver's License and shipping disclaimer
- 2. Shipper must use Delivery Confirmation Adult Signature Required and Direct Delivery Only services for each package containing a Firearm, including a handgun or a Firearm suppressor, and affix a UPS label requesting an adult signature upon delivery.
- 3. All Firearm Products must be shipped in new corrugated packaging that meets the UPS Single Wall Box Strength Guidelines.
- 4. All Firearm Products must be packaged in accordance with UPS Packaging Guideline Specifications.
- 5. Ammunition must not be in a gun. Best to not ship any ammo whatsoever.
- 6. The labeling and outer box markings on all Firearm Products shipments must not identify the contents as containing Firearm Products. Labeling, including the shipper's and consignee's abbreviated names on the shipping label or air shipping document, must be non-descriptive.
- 7. Handguns must be shipped Overnight or overnight only.
- 8. Long rifles or shotguns are allowed to be shipped normally. Adult signature isn't required to FFL, but will be required to send back to sender.
